Format to be used for inward remittances in certain major foreign currencies

Branches are requested while handling Foreign Inward Remittances in favour of their customers should take utmost care as follows:-

1. Branch should first ascertain from the beneficiary customers that how the remittance effected/will be effected. The remittance may be effected in two ways. In case the remittances are made by the foreign bank in abroad in such a manner that the amount of the foreign currency remittance is directly credited to our foreign currency account abroad (Nostro account). In such cases only the following format should be used.
2. In case the inward remittance is to be received finally in Indian Rupees through remitting bank's (in abroad) agent / branch office in India the following format must not be used.
3. In case the remittances to be received in Indian Rupees from abroad by the remitting bank's agent/branch office in India the branch should furnish their IFS Code No. and account No. of the beneficiary only as used in RTGS/NEFT
